## Information Clause

Pursuant to Article 13 (1) and (2) Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) GDPR, we hereby inform you that:

1. The administrator of your personal data is Lodz University of Technology with its registered office in Lodz at Żeromskiego 116, nip: 727-002-18-95, tel. +48 42 631 29 29 represented by the Rector.
2. The administrator has appointed a data protection officer, with whom contact in matters related to the processing of personal data is possible at the e-mail address: iod@adm.p.lodz.pl, tel: 42 631 20 41 or in writing to the administrator's address.
3. The purpose of processing personal data is to record and record the image in materials, social media and on information and promotional channels of Lodz University of Technology.
4. You have the right to withdraw your consent to the processing of personal data at any time, but this does not affect the lawfulness of the processing that was made on the basis of consent before its withdrawal.
5. Personal data will be stored indefinitely or until the consent given before the image is published is withdrawn.
6. The data subject shall have the following rights:
  - Pursuant to Article 15 GDPR right of access to their personal data;
  - Pursuant to Article 16 GDPR Right to rectification of personal data;
  - Pursuant to Article 18 of GDPR, the right to restriction of processing, except for cases referred to in Article 18 (2) of GDPR;
  - the right to file a complaint to the President of the Personal Data Protection Office, if they decide that the processing of personal data relating to you violates the provisions of GDPR,
7. Providing data is voluntary, but necessary to achieve the purposes referred to in point (3).
