**Regulations for funding mobility
in the project titled: "IMPROVE - International Mission
for the Promotion of Research and Optimal Values in Education",
implemented by Lodz University of Technology under the programme
STER – Internationalization of doctoral schools – 2024 Call, financed by NAWA**

Due to the adoption of the flat-rate principle in the STER programme in relation to the costs indicated below, Lodz University of Technology will not require the Participants to provide accounting evidence of the expenses incurred, with the exception of the situation described in §8(6) of the Regulations (force majeure).

Co-financing living and accommodation costs

Co-financing accommodation and meals for each full month of the doctoral candidate's stay at the foreign host centre, lasting 1 to 2 months, amounts from **4,000 PLN to 12,000 PLN per month** depending on the group of countries – according to the table below.

Settlement of living costs is based on the submitted certificate (Appendix 1 to the Agreement), specifying the dates of the start and end of mobility.
